- Steady increase in discipline issues (growth and COVID are contributors)
- Each “incident” is recorded in Infinite Campus by assigned staff
- Teachers are being taught how to enter behaviors into IC as well – Rewards and disciplines for tracking purposes

- Chronically Absent = more than 10% of class periods
- No data from 2019 or 2020 due to COVID
- Attendance rates of absent students are increasing – what is CECW doing?
 - Restorative Practices
 - Eye to Eye – Neurodiversity
 - Counselor groups
 - Safe, loved, secure, sense of belonging education to students from staff and teachers

3. Safety & Security @ CECW

- 1 main entrance
- Classroom doors are locked and have blinds – to be closed in an emergency
 - New blinds in art room, library, robotics, and STEM room
- “Locks, lights, out of sight” model used
- Raptor management for check-in/check-out – ID Check system
 - Screens visitors
- ID badges are required for all staff and students
- CEC Windsor is a demo school for Raptor Secure System
- Testing the Raptor System for drills and security
- Practice drills for all staff and students
 - 2 times monthly – fire and evacuation
 - Other drills – secure, hold, lockdown shelter - Quarterly
- Lightspeed for safety (searching inappropriate topics, self-harm, harming others, etc.)



- False positives have occurred (e.g. Shakespeare units)
 - To roll out Nov 1 for teachers to be able to monitor in real-time what students are doing.
 - Lightspeed only to be used on school tech – not on students or staff personal phones or computers
 - New security cameras added to “blind spots” - Possible addition of these over Fall Break
 - CECW follows the Standard Response Protocol and Standard Reunification Model from the iloveguys foundation
4. Question on school consolidation impact
- PSD closing two schools and consolidating. Parents would like to start the conversation about “what if?”
 - Kelly and Rebecca are consistently working with CEC’s CEA, CFO, & COO to make the best decisions to ensure CECW is viable and responsible
 - We can and should learn from PSD’s mistakes – full transparency on budgeting and curriculum to parents when changes are occurring, and parent voice is important
 - SAC committee agenda items are currently set to discuss curriculum review and fiscal reviews
5. Additional Questions:
- What are the best practices for parents to keep kids accountable on assignments?
 - Teams, Planners, Infinite Campus
 - Teams is available to all students at home
 - Planners should be used for all homework assignments – many students do not bring their planners to class
 - Parents are encouraged to email teachers directly with questions
