## **Correspondence/Board Comments**

- Jessie Mathis Free Meals for Students
  - Jessie asked how CEC students were taking advantage of free meals this school year. Sandi shared the number of students accessing free meals at all campuses. CEC has seen a drop in families submitting Free and Reduced Lunch applications as a result of students receiving free meals this school year.

#### Administration Report – Sandi Brown

- Academics
  - Summary CEC Parker/CEC Inverness Parent Town Halls
    - Sandi recapped the feedback received from families regarding the CEC Parker/CEC Inverness merger. Vast majority of feedback is positive with only 3 negative emails received. Both School Accountability Committees are excited about the merger. Students/families are looking forward to spring advising and seeing the expanded course offerings. Questions center around 4 main topics: transportation, staffing, course offerings, and the Freshman Academy. Sandi thanked Terry M. for attending a CEC Inverness Information Meeting and tour for CEC Parker families.
  - o Director of Exceptional Student Services
    - CEC will hire a Director of Exceptional Student Services at the Network to oversee and assist all schools.
  - 1215 Taskforce Update
    - Sandi recapped the recommendations coming out of the 1215 Taskforce. She noted that no Early Colleges and no CSI schools were on the taskforce. The proposed recommended changes could affect 10% of CEC students. Sandi let the Board know that CSI Board members, attorneys, and charter school groups are rallying to help oppose the recommendations that dramatically affect the Early College model.
  - My Tech High Update
    - Uncertainty remains on if the state will fund the My Tech Program for 2023-24 school year. Sandi has asked for an early audit to make sure that CEC and My Tech High are in compliance with the new CDE audit guidance.
  - Access to Medically Necessary Treatment Policy
    - This is a new policy as a result of legislation. CEC worked with legal on the policy and all Heads of School and School Nurses have been trained.
- Marketing and Enrollment
  - Enrollment for 2024-25 School Year Opened November 1
    - Enrollment opened November 1, 2023 and CEC has enrolled more new students than this time last year.
  - CEC Impact Report
    - This will be CEC's 2<sup>nd</sup> "annual report" and will be distributed before the end of the semester.
- Operations/Safety
  - o SSO Update
    - Operations staff visited a local school that employs armed security. Sandi noted she has met
      with the security company and that the security company will present to Board members
      and school leadership in Executive Session at the December Board meeting.
- Quarterly Facilities Update
  - Sandi highlighted several facilities projects currently underway including the development of an Innovation CTE Center (Daniels Fund) and courtyard improvement (Anschutz) at Colorado Springs, CEC is in line to receive the 2023 CDE BEST grant to replace the CEC Fort Collins High School roof in summer 2024, and both the Parker building and Wheaton building will be listed on the public market soon.
  - A new Facility management team member has been hired to support the CEC Colorado Springs campus.
  - The Facilities team is developing a master maintenance plan for all buildings.

#### Finance – Cameron Mascoll

- First Quarter Financials
  - Cameron told the Board there are no red flags regarding 1<sup>st</sup> quarter budgets. Work has started on budget reforecasting, and he reminded the Board that they will review and approve amended budgets at their January meeting.
