Administration Report – Sandi Brown

Academics

- Colorado Springs 2023 Graduates Two 2023 graduates from CEC Colorado Springs shared their experiences at CEC Colorado Springs, including why they chose CEC, what credentials they are earning at graduation, and their future education and career goals. Laura thanked the graduates for attending and congratulated them on their achievements.
- 2022-23 Enrollment Update Sandi informed the Board that enrollment for 2023-24 is going exceedingly well and highlighted that CEC had 88 graduates in December.
- Founder's and President's Scholarship Awards Process Sandi updated the Board on the upcoming 2023 Founder's and President's Scholarship Awards Process.
 - Board will receive nominations week of March 27, 2023
 - Deadline for Board selections is April 5, 2023
- SAC Mid-Year Reports- All schools have active School Accountability Committees this school year with lots of parental involvement.

Marketing

- Refresh to Marketing Department The CEC Marketing team is taking a proactive approach in supporting all schools with enrollment. CEC also has a robust presence on the Niche website which helps families find schools across Colorado.
- <u>CEC Parker Alumni Project</u> CEC is piloting an alumni association at CEC Parker and is engaging with former students to find their level of interest in reconnecting with CEC and becoming a resource to current CEC Parker students. CEC Colorado Springs will be next in forming an alumni association.

Operations

- Transportation Department Re-organization and Streamlining Process to Serve More Families –
 CEC is taking a deep dive into our transportation services with the goal to more effectively serve families who need transportation through targeted bus routes/stops.
- All CEC Students Will Eat for Free 2023-24 School Year CEC will feed all students for free in the 2023-24 school year and has a renewed focus on its farm-to-school program. Construction starts next month on the Colorado Springs scratch kitchen.
- Facilities Sandi provided an update on all building leases as well as an update on current building improvements and upcoming construction projects.

Finance - Cameron Mascoll

- <u>2nd Quarter Financials</u> Cameron noted that 2nd Quarter Financials matched the amended budgets and noted there are no red flags. He informed the Board that CSI's GrantVantage still needs to be updated and that could result in some changes to school grants.
- Amended Budgets Cameron stated that CEC is still receiving updated FY23 financial information which
 could impact FY23 final budgets. Cameron will keep the Board apprised of updates and will let the Board
 know that there could be a need to amend budgets again before the end of this fiscal year.
