- COVID Update Sandi presented the current pivot plans for all schools to pivot from in-person and hybrid learning to remote learning depending on the various County health department input, and staff requirements. She did note that CEC Parents are in favor of in-person learning, but we will continue towards that goal in a safe manner in the weeks to come.
- CEC Buildings and Lease Update Report Michelle Fisher presented our current building project updates. Michelle also highlighted our CECFCMS West partnership with the Boys and Girls Clubs.
- Schools Update Michelle presented this along with the Lease Update Report.
- Colorado League of Charter Schools and Other Alliances
  - Sandi shared that, post-election, or Colorado Legislative Climate remains very similar to how it was last year. We will continue to partner with the League of Charter Schools to stand up for charter school legislative support.
- Presentation of Grant Topic-Based Webinar Dr. Stephanie Livingston presented to the Board training from what she learned at a recent Webinar on the 3 C's of Mental Health and how that affects students and staff.
- In preparing for new student informational meetings, Sandi shared a few of our milestones:

### Since 2007, CEC has:

- o Graduated 1,546 students with associate degrees
- Helped students earn 165,000 college credits
- Saved families \$31,219,633 in tuition, fees, and books
- o Graduated 2,955 students with some college credit
- o Enrolled 4,659 student across the CEC Network of Schools
- o Grown 1,259% since inception
