# **Correspondence/Board Comments**

- Larry shared about his conversation with fellow travelers regarding CEC, with one being a recent CEC graduate.
- Sandi shared that January is Board Appreciation Month and thanked Board members for their service to CEC. It was shared that Board member profiles were being featured on LinkedIn.

## Administration Report – Sandi Brown

- Academics
  - Daniels Grant Presentation Wendy Rhodes, Director of Postsecondary Workforce Readiness and Kathleen Kingdom, STEM Coordinator
    - Wendy and Kathleen presented how CEC is using the Daniels Grant to enhance the Career and Technical Education (CTE) offerings at the Colorado Springs campus. They shared how CEC is using the funds to expand STEM, Health Sciences, and Multimedia pathways for students.
    - Sandi mentioned that CEC has 5 Daniels Scholarship Finalists 2 at CEC Fort Collins, 1 at CEC Aurora, and 2 at CEC Douglas County.
  - Founder's and President's Scholarship Awards Process
    - Board will receive nominations the week of March 11, 2024 via Teams
    - Deadline for Board selections is Monday, April 1, 2024
      - Sandi highlighted the deadlines above.
  - SAC Mid-Year Reports
    - Sandi noted that the 2023 Mid-Year School Accountability Committee (SAC) reports were the best reports received to date. She encouraged the Board to take time and read them.

#### SSO Update

- Sandi mentioned this discussion would happen later in the meeting under "Other Business" on the Board's agenda.
- My Tech High Audit Update
  - Sandi noted that CEC, My Tech High (MTH), and CSI met the Colorado Department of Education (CDE) deadline for submitting all documentation for an early audit of the MTH program. CEC has not received news from CDE regarding the audit's findings, but was told by the commissioner that the audit would be completed by January 31, 2024.
  - CEC also sent a formal notice to MTH to reduce liabilities should the audit not be favorable. Sandi will inform the Board of the audit's outcome via email if the audit findings are received prior to the February Board meeting.
  - CEC asked for an analysis of how the changes to the School Finance Act could impact CEC's Early College model programming. MTH asked for an analysis of their program as well.

#### Facilities

- Update on Sale of Parker and Wheaton Buildings
  - Sandi informed the Board that both buildings are up for sale and that a "moving" banner is now up at Parker. There was a walk though of the Parker building by an interested investment group.
  - CEC is doing its due diligence with Academy of Arts and Knowledge (AAK) with regards to condo-izing the Wheaton building. AAK is interested in purchasing only the 1<sup>st</sup> floor.
  - Liberty Common has until June 30, 2024 to exercise the option to purchase the former CEC Fort Collins West building.
- Out-of-State Employees and Payroll Taxes
  - Sandi provided Board members with information regarding out-of-state employees and payroll taxes in their Board packet.

## Finance – Cameron Mascoll

- Amended Budgets
  - Cameron thanked the Heads of School and their Business Managers for their work on amended budgets. Overall, he stated that CEC is in a good place and has a good fund balance.
  - Larry and Art, members of the Board's Finance Committee, echoed Cameron's comments in that
     CEC is in good financial condition and that the budgets looked sound.

 Cameron reminded the Board that state law requires schools to amend their budgets by January 31 of each year.
