#### Other Business

- Fish asked if any Heads of School/staff had objections to the SSO initiative. The Board agreed that there were many discussions held on the subject and Fish withdrew his question. The Board reiterated that they would like to hear from staff and Heads of School regarding concerns.
- Supplemental Online Committee Report and Next Steps
  - Laura and Fish, members of the Board's Supplemental Online Committee, reported that after meeting with the CEC Executive Leadership Team a supplemental online program will not be implemented for the 2024-25 school year. The committee will revisit the possibility of offering a supplemental online program in the future.
- Discussion on New Location for CEC Everest Point Homeschool Academy Outside Douglas County School District
  - Dustin informed the Board of that the new location for the Douglas County campus of CEC Everest Point Homeschool Academy is actually located in Cherry Creek School District. CEC cannot operate outside a district in which it is not charter and CEC cannot offer a complete program outside its charter district. In Dustin's opinion, CEC Everest Point Homeschool Academy is not a complete program and in talking with CSI, they are not opposed to CEC Everest Point Homeschool Academy's move.
  - Jessie made a motion to amend the agenda and add "Approve CEC Everest Point Homeschool Academy Location to be outside the Douglas County School District." Larry 2<sup>nd</sup>. Approved. The meeting minutes reflect this change.
