- Discuss CEA Hiring Process
  - The Board was reminded that they passed a resolution at their March 9, 2024 meeting to proceed with the hiring of the CEA position at the discretion of the Board's HR Committee.
- Discuss Insurance Selection of Counsel
  - Larry made a motion to authorize the Charter School Law Group to respond to and work on an insurance claim. Terry 2<sup>nd</sup>. Approved.
- Resolution 2024-05-03-A Regarding Supplemental Online Education Options
  - Dustin updated the Board that CDE's audit of the My Tech High program was not completed, but CDE did send an email stating they will fund the MTH program for this school year.
  - The resolution creates an "Supplemental Programs Committee" to work with CEC staff to determine options for offering supplement online programming, grades 6-12, for the 24-25 school year. Committee members are Laura Calhoun and Fish Abrhaley.
  - Larry made a motion to approve Resolution 2024.05.03A Regarding Supplemental Online Education Options. Terry 2<sup>nd</sup>. Approved by roll call vote:

- Discuss Postponing the May Regular Board Meeting to May 23, 2024
