Administration Report – Sandi Brown

- Marketing and Enrollment
 - All schools are doing well with enrollment and, as a Network, CEC is over its budgeted FTE goal.
 - o Enrollment for the 2024-25 school year opens November 1, 2023

Academics

- Daniels Fund and CEC Colorado Springs CTE Programming and EPHA Programming
 - CEC was awarded \$500,000 over 2 years to support programming and equipment for CEC Colorado Springs CTE pathways, and to support Everest Point Homeschool Academy at Colorado Springs.
- School Performance Data Summary Ryan Marks Attending October Board Meeting
 - Ryan Marks will attend the October 13, 2023 CEC Governing Board Meeting and review the CARS reports with the Board.
 - Schools will work this coming year to increase student participation in state assessments.
- o MTH and Homeschooling in the State of Colorado
 - CDE is instituting new funding rules for this October Count that focus on student/teacher instructional time as well as how attendance is taken in order to "count" a student for funding.
 - Sandi is working with CSI and Dustin to ask for more time to enable MTH to comply with the new funding rules. CEC is collaborating with 2 other Colorado school districts who also offer MTH to their students.
