- CSI Charter Renewal Kick Off Overview – Ryan Marks, CSI, presented the upcoming Renewal timeline:
 - Officially moving into the charter renewal process for CECFC, CECA (August) and CSEC (October).
 - The Board needs to provide a budget and 3-year forecast as a financial review.
 - The Board strategic plan – a part of the administrative renewal process.

- CSSI Visit Summary for CEC Windsor and CECFC West MS – Erin Sciscione, CSSI Team Lead (Consultant), Presented a high-level review of the CSSI reports.
 - Summary report Highlights:
 - Windsor: Curriculum maps, teachers able to relay teaching plans well, MTSS system was clearly developed, great documentation efforts, teachers’ voices heard through surveys and conversations, students felt safe and comfortable, comradery, trusted leaders and teachers.
 - Windsor focus areas: gaps in the data provided for staff to make data-driven analysis and decisions. The recommendation of making really clear leadership roles in data cycle/goals, feedback on progress and coaching support.
 - CECFCWest Highlights:
 - A high-degree of confidence in leadership and staff seem very happy at this school.
 - Implement a systems-thinking approach to school-wide changes to build staff-wide buy-in and understanding of data and goals.
 - Collect data on “Why choosing initiatives?”
 - School-wide analysis and prioritize goals.
- CEC Buildings and Lease Report
 - Putting in acceleration lane and bike lane for CEC Windsor.
 - Bringing in Skills Academy as new partner in CSEC.
 - AXIS Lease update, Enterprise Rental Car/Boys and Girls club lease update. (Wheaton)
 - TPAAK and Spider Monkey (rental lease update).
- 2021-22 Enrollment Goals – Sandi gave update on enrollment and marketing. MyTechHi enrollment up! In general – many parents seem to be waiting to enroll students depending on how Fall protocols are published, and homeschooling is up across the state. PPR projections are that we will NOT have a decrease in PPR for next year.
- Graduation Projections for Class of 2021
 - CSEC graduating 95% of grads with degrees or credentials!
 - CECA is graduating 65% of grads with degrees or credentials!
